Dear Secretary Cardona,

We are writing to express concerns with a recent proposal made by the Department of Education (Department) to halt the collection of information that is essential to protecting the safety of students in our nation's public elementary and secondary schools.

As you know, the Department's Office for Civil Rights (OCR) conducts the Civil Rights Data Collection (CRDC) every two years. Through the CRDC, the Department collects a variety of information from public schools that enables OCR to enforce civil rights laws that protect students from discrimination on the basis of race, color, national origin, sex, and disability. For the CRDC conducted during the 2020-2021 school year (delayed by one year because of the onset of the COVID-19 pandemic during the 2019-2020 school year), the Trump administration added questions related to incidents of alleged sexual assaults committed by teachers and other school staff. You have proposed eliminating those questions from this year's collection.

When parents send their children off to school each morning, they trust the teachers and other staff to teach those children and protect them from harm. We know the overwhelming majority of teachers and staff take this sacred trust seriously and do everything they can to provide students with a safe and welcoming educational environment. However, we also know that exceptions exist.

Four days after the Federal Register published the Department's proposal to eliminate questions related to sexual assault by staff, the story of a chemistry teacher who sexually

harassed multiple students over his 24-year teaching career was reported in California.<sup>1</sup> One former student has sued the teacher for allegedly sexually assaulting her repeatedly between 1999 and 2003. Unfortunately, records show that for at least 15 years, a series of administrators ignored complaints from students about the teacher's behavior.

This is why the Trump administration introduced these questions to the CRDC. Parents deserve to know if administrators and local officials are ignoring allegations of sexual assault by staff against students. The only way for parents to get this information is if school districts are required to report it. Unfortunately, this proposed action by the Department continues the Biden administration's troubling trend of undermining parental rights in education. The Biden administration has repeatedly demonstrated that it cares more about the self-interests of teachers unions than the best interests of children.

To be clear, these are the data elements you have proposed to eliminate from the CRDC that we are concerned about:

- 1. Number of allegations made against a school staff member of rape or attempted rape, or sexual assault that occurred at the school, which were followed by a resignation or retirement prior to final discipline or termination.
- 2. Number of allegations made against a school staff member of rape or attempted rape, or sexual assault that occurred at the school, which were followed by a determination that the school staff member was responsible or not responsible for the offense.
- 3. Number of allegations made against a school staff member of rape or attempted rape, or sexual assault that occurred at the school, which had a determination that remained pending.
- 4. Number of allegations made against a school staff member of rape or attempted rape, or sexual assault that occurred at the school, which were followed by a duty reassignment prior to final discipline or termination.

With respect to these data elements, please provide the following information to my staff no later than December 17, 2021:

- 1. All emails and other communications among Department staff about the removal of these data elements from the CRDC.
- 2. All emails and other communications between Department staff and any staff of a national or local teachers union about the removal of these data elements from the CRDC.
- 3. All emails and other communications between Department staff and staff in the Executive Office of the President about the removal of these data elements from the CRDC.
- 4. A detailed rationale for the proposed removal of these data elements from the CRDC.
