Dear President Trump:

We write to you ahead of Prime Minister Takaichi Sanae's visit to request that you urge the Prime Minister to open Japan's market to U.S. fresh (table stock) potatoes. Gaining fresh access to Japan would result in an estimated \$150 million a year in new American potato exports. Put in perspective, new market access would make Japan the largest export market for U.S. fresh potatoes outside of North America and bring tremendous benefits for farming communities in our states.

U.S. potato growers produce the best potatoes in the world. International trade and foreign export markets are critical to the U.S. potato industry. About 20 percent of American-grown potatoes are exported around the world, contributing nearly \$4.8 billion in economic growth and supporting nearly 34,000 jobs in the United States. U.S. growers have a long history of exporting fresh potatoes to markets across the Indo-Pacific, including South Korea, Taiwan, Hong Kong, Singapore, Indonesia, the Philippines, Malaysia and Thailand. These exports occur safely and on a routine basis, providing mutual benefits for consumers abroad and growers here at home.

Japan, however, continues to shut U.S. potatoes out of its market with no scientific basis. The United States first requested fresh potato access in Japan over thirty years ago; the market access petition was elevated to a top priority in U.S.-Japan plant health negotiations in September 2019. But since then—despite the efforts of the U.S. Department of Agriculture's Animal and Plant Health Inspection Service and the Office of the United States Trade Representative—Japan continues to delay substantive technical discussions on table stock potato access. There is no valid phytosanitary justification for these delays.


With low commodity prices and increased input costs this year, the potato sector, and specialty crops more broadly, are facing a major economic crisis. Japan represents a massive market with significant export opportunities for American potato growers. Securing this long-delayed market access petition and unlocking the critical Japanese export market would make a meaningful difference for potato growers in our states and across the country.

Technical discussions have not made meaningful progress. We urge you to prioritize this issue in your discussions with the Prime Minister and find a lasting solution for U.S. potato growers. Thank you for your attention to this important matter. We stand ready to assist as needed.
